2. Agency Service Fees: For every hour the nanny works, \$8 is paid directly to the agency (\$32 minimum). If families are sharing a nanny (not siblings) the hourly rate is \$12 (\$48 minimum). Fees are charged to your credit card.

3. Policies

- ✓ Minimum four (4) hours per sitting.
- ✓ Cancellations before 48 hours will only be charged a \$15.00 processing fee per date. Cancellations within 48-hours will be charged the 4-hour minimum, in addition to a 10% service fee per Nanny. Fees are charged to your credit card.
- ✓ Time-and-a-half if service exceeds 8 hours per sitting & Holidays. Double-time if service exceeds 12 hours per sitting.
- ✓ If immediate payment is not made directly to the nanny, the parent/guardian agrees that the agency will charge their credit card the following: 20% gratuity to the nanny & 10% service fee to the agency will be added to the total amount due.
- ✓ Gratuity is optional if payment is made directly to the nanny.
- ✓ Please notify the office for additional requests, as well as time changes.
